

## **Bachelor exchange – course offer 2026-2027** (under regular reservation)

### **Bachelor exchange to RSM requirements**

As mentioned also in our factsheet, the exchange to RSM is open to third year (or fourth year) bachelor level students who are studying at our Bachelor partner schools and are selected by their home university. Students need to meet our English level requirements as mentioned in the factsheet:

- TOEFL iBT: 80+/4.5+ overall (minimum sub score of 18/4.0 for reading & listening, and 20/4.0 for speaking and 21/4.5 for writing).
- IELTS: 6.5 overall (minimum sub score of 6.0 for reading, listening, speaking, and writing).
- CEFR level B2.
- Cambridge FCE/CAE/CPE/BEC Higher: 170 overall (minimum sub score of 170 for reading, listening, speaking & writing).
- Pearson PTE score of 70+; minimum sub score of 65+ for reading, listening, speaking, and writing.
- LanguageCert Academic score of 70+; minimum sub score of 65+, for reading, listening, speaking, and writing.

Other English language certificates of a comparable level may be accepted as well, but please check with us. No statements from universities are accepted, except for statements confirming the education is English taught.

### **BSc courses, minors, electives & modules from tracks**

Visiting exchange students can enroll in courses from all three Bachelor years of our BSc International Business Administration programme. Almost all 1<sup>st</sup> and 2<sup>nd</sup> year courses open to exchange students offer enough spots to allocate all students. In the 3<sup>rd</sup> year courses and some of the other courses, spots may be limited and are allocated mostly on first-come, first-served basis.

### **Exchange Fall term**

The fall term offers courses in blocks 1 and 2 in all three Bachelor years.

Courses in block 1 are offered in the first half of the fall term (September-October/November) and courses in block 2 are offered in the second half of the fall term (October-December).

Courses from different Bachelor years can have an overlap in the timetables. All students are required to participate in the **full** fall term. Therefore, all students need to participate in courses in both the first half and the second half of the fall term.

### **Workload requirements**

In the fall term, students need to obtain a minimum of 20 EC in total. The maximum number of credits for the fall term is 30 EC, although we strongly advise not to surpass 24 EC. Only the credits of the courses passed count towards this minimum requirement.

## RSM fall minors

Minor courses are offered in fall only, and they have a workload of 15 EC. A minor is a combination of 2-3 courses that specialize in one subject. As it is one course, there is no subdivision of the credits possible. It is comparable to a major, only smaller in size and workload. Students can only participate in one minor; they may rank up to 3 preferences in total when applying for a minor. Spots are limited, so the application period starts early. ### Exchange periods

In the spring term, we are offering 4 different exchange options. Each exchange option has a different starting and/or ending date, with different minimum required workloads. With this offer, we hope to fit most student's requests for periods of stay during their exchange.

We do request students to participate in courses throughout the entire period of stay. It is not allowed to have a period of more than 1 week without participating in courses.

Exchange periods are indicated by the partner universities upon nomination of their students. We also ask the partner universities if their students are allowed to select a different exchange period. This way, if they do select a different period, we can just proceed with their application without having to first check with the partners and delay the process.

The course registration will take place in different stages, starting with the courses that are offered at the start of the spring term.

There are 3 tracks in total that allow students to follow their field(s) of interest and to prepare for a master. Students can participate in max. 1 module per block.

Some changes to this information may occur, but in that case, we will inform the students once we are informed. Students cannot participate in more than one module per block due to the limited spots available.

## Additional information RSM courses (minors/electives/modules/courses)

### Course catalogue

Students can find information on the courses in the course catalogue. Just type in the course code of the course concerned to be directed to the information. We aim to have all updated information published about two months prior to the start of the courses. Until the updated information is available, students can check information from the year before.

### Course manuals & timetables

The course manuals will be published about 1-2 weeks prior to the start of the courses. We aim to publish the new timetables around mid-July. These will be published on the platform Canvas and are only available to students enrolled in the course concerned.

The timetables will also be published around mid-July via MyTimetable. Students will have to login to get access to the timetable information. The link to MyTimetable will be shared before the new timetables are published.

### Course application/registration

Nominated students will receive information from the Exchange Office on how and when to apply/register for courses. Some of the information on courses and registrations provided on the regular online channels for students may vary for exchange students. The Exchange Office will inform students further about this.

### Class schedule / exam registration

It is the students' own responsibility to ensure that the schedules of their selected courses do not overlap. This also applies to exams and re-sits.

Once enrolled in a course, the student is automatically registered for the regular exam. If a student fails a course, they will be automatically registered for the re-sit. More information and instructions on re-sit registration are passed on to the students in due course.

## Courses at other faculties

Next to the RSM courses, students can also participate in a course from some of the other faculties of the Erasmus University Rotterdam. The faculties that accept our students are e.g. the Erasmus School of History, Culture and Communication (ESHCC, including IBCOM) and the Erasmus School of Social and Behavioural Sciences (ESSB). The information and registration of their courses go directly via the faculties. Exchange students will receive information on how to contact the faculties.

Some of the other faculties may also accept our students after a request from the student. E.g., the Erasmus University College (EUC) also offers a few courses in which they accept some of our students. Please note though, that spots are very limited at EUC, and this faculty is not on campus, but in the city centre of Rotterdam.

Last year students were also be able to participate in a course at the Erasmus School of Economics. The evaluation of this initiative is scheduled for this summer. Should the evaluation prove successful and the collaboration continues, we will provide detailed information about the course offer and possible prerequisites to nominated students via email.
