1. Opening and announcements

The chair welcomes everybody present.

2. Approval of the Minutes from the MSc PC on 30 October 2025 – see attachment The Minutes were approved. .

3. Information about the Annual report 2024-2025 being ready

MS informed the Committee about the MSc PC annual report 2024-2025 is ready.

1) The annual report has been uploaded in the folders Meeting 27 November 2025 and How the PC works in the MSc PC Teams environment.



- 2) The annual report is important to the committee members to find information about las year's subcommittees. In addition, the solicited and unsolicited topics, together with the appendices discussed by the committee last year, are also included in the report.
- 3) AL will upload the annual report 2024-2025 on the MSc PC website.

4. Information launch of the Dean of Education project on RSM Assessment Policy

MS updated the Committee on the launch of the project by the Dean of Education concerning RSM's Assessment Policy.

- 1) The chairs of the participatory bodies have been approached by the Dean of Education with information about the project Assessments Policy will be launched.
- 2) The project is about how to revise RSM's assessment policy (assessments refers to the way grades are generated),
- 3) The proposal is to use a closed list of allowed assessments instead of the current situation in which teachers are also the examinators and are allowed to design the type of assessments,
- 4) The reasons for the proposal are a) RSM has been approached by the Miniter of Education and accreditation bodies to provide good argumentations that students graduate the students upon graduation own all the skills and knowledge they have learned during the study and aren't influenced by ChatGPT. With the listed exams and assessments RSM can indicate that graduates have completed all the types of exams and assessments on the list and therefore, it would be impossible to cheat using AI, b) With the different type of assessments in the current situation, before the courses (manual) is launched it's difficult for the Examination Board (EB) to assess whether an assessment is valid or not. If there is an assessment list, it would be easier for the EB to check the assessments and c) With a closed list of assessments, it would be easier to monitor the continuous improvement of Education as there are fewer types of assessments.
- 5) A taskforce has been created consisting of Al expert Dimitrios Tsekouras, the Learning Innovation Team, Academic Directors, teachers and students,
- 6) The idea is to launch the closed list as a pilot across some master programmes.
- 7) The Programme Committees have given the Dean of Education the following recommendations a) Communicate to faculty what administrative burden related to different forms of examinations exist because there is much diversity in exams, b) When formulating the list of allowable assessments, consider the impact both policy transition and the new policy itself on faculty workload. Increased workload can impact the quality of education negatively. Consider using as input examiner workload estimations created by FI department, c) Roll out the updated policy in stages to allow programme and teachers to adjust properly, d) Allow Academic Directors to choose which courses will use assessments from the list and which ones won't need to do it, e) Create a structural, permanent and transparent process of updating the assessment list in the future and f) Create and share a list of criteria applied in assessment method selection to create transparency in terms of why certain assessment methods are selected and not others. Among others, it's important to know if a given criterion is related to Al fraud or to facilitation of the administrative processes.

Comments of the Committee:

- 1) MS: In the past, RSM wanted to use student course evaluations to identify problems and space for improvement but a dashboard has been created that uses assessment results to identify problems. According to MS, average grades which are dictated by the difficult of exams and the quality of teaching would be used. However, for teachers, it would be easy to set easy exams that students don't complain about. In addition. MS indicated that this could be a topic for the Quality of Education subcommittee.
- 2) MA: The majority of departments allocate the fictitious money to courses. Therefore, it would be better to consider that RSM should use one of the official assessments methods, for example an oral exam that is more directly integrated into the allocation of the fictional money to the course. This is important because it probably influences teachers' decision to use an assessment method from the list.



- 3) LC: It would be a good idea to ask about the exemption procedure and how it will work.
- 4) LC: It would be good to ask whether the PC could receive the draft closest assessment method list thus it's visible what types of assessments are included and what the impact will be.
- 5) RG wonders who created the type of assessments list. The Dean of Education or the people who design the courses?
- 6) RD agrees that not every single assessment should be approved, as long as a sufficient number of assessments are approved. In addition, he indicated that students can't use Al during exams on campus
- 7) RG: It would be better if RSM took students AI literacy into account, as this is a requirement on the current labour market, and therefore an important skill for students to possess.
- 8) LRS wonders what the costs are of the administrative processes whether they are related to the work of the EB or whether they are also related to the exam organisations. Moreover, she wonders how do they balance AI exams, as on campus exams could increase the costs of assessments
- 9) TM: It would be important that the type of assessments corresponds with the learning goal. Therefore, it would be important that the MSc PC pays attention to the variation of different types of learning goals on the list
- 10) TM wonders whether this project isn't let by the EB because the topic concerns assessments and therefore relates to examination. Therefore, the MSc PC should ensure .that the EB is involved in this project
- 11) TM: Because the assessment policy is a topic on the PC agenda, it would be better if the information about the topic should be shared with the members in advance thus they are prepared before the meeting.

5. Subcommittee formation

During the meeting, the following subcommittees have been established (see table). Members who don't yet have a subcommittee could indicate in the table which subcommittee they would like to join but they can only choose from the subcommittees whose status is listed as open.
